Except as otherwise provided by New Jersey statute or regulation the bee to be charged to a recipient for the duplication of a printed record shall be \$0.05 per letter size page or smaller and \$0.07 per legal size page or larger unless the larger item cannot be copied on a standard copy machine of the municipality. In that event the recipient shall be charged the actual cost incurred by the Municipality to have the item reproduced by an outside entity.

- D. Access to electronic records and non-printed materials shall be provided free of charge except that the recipient will be charged for the actual costs of any needed supplies such as a computer disc in those cases where such electronic media is reproduced and copied for the recipient.
- E. In those cases where the Township of Liberty is issued a check, draft or other negotiable instrument for payment to the Township and the aforesaid check, draft or instrument is not honored for payment upon presentation then in that event the issuer of the aforesaid instrument shall pay the Township of Liberty a fee of \$35.00 (Thirty-Five Dollars) foe each instrument so issued to the Township.
- 3. All of the other terms and provisions of Liberty Township Code Section 59-1 shall remain in full force and effect.

MUNICIPAL ENGINEER

Position Established.

- 1. Pursuant to the provision of NJSA 40A:9-140, there is hereby established in and for the Township of Liberty the position of Municipal Engineer.
- 2. The Municipal Engineer so appointed shall be duly licensed in the State of New Jersey and the aforesaid license shall be in good standing at all times during the term of the appointment.

Duties.

- 3. The Municipal Engineer shall perform such duties as are prescribed by statute and in addition:
 - A. Prepare or cause to be prepared, specifically as directed by the Township Committee, plans, designs and specifications for public works and improvements undertaken by the township either by account or by public contract

B. Provide and maintain surveys, maps, plans, specifications, tax maps and control records with respect to public works and facilities owned or operated by the Township

- C. Provide technical and engineering advice and assistance to other township officers, as needed.
- D. Attend regular meetings of the Township Committee as needed, and such additional meeting as directed or requested by the Township Committee.
- E. E. Perform such other duties as are now and hereafter imposed by statute, regulations or by municipal ordinance or regulation.

Term of Office.

4. The term of office of Municipal Engineer shall be for a period of one year, to commence on 1 January of the year in which the appointment is made.

Compensation.

5. The Municipal Engineer shall receive such compensation as authorized by the Township Committee. All invoices for engineering services shall be subject to Township Committee approval.

Hiring of Additional Engineering Services.

6. Nothing in this article shall prohibit the Township Committee from hiring, appointing, consulting, employing or contracting with other engineers, engineering firms or Companies if it is determined by the Township Committee that such services could be better obtained through another engineering firm.

WHEREAS, Among other things, A3766/S2664 limits the obligation of a cable company to provide cable and internet connections to municipal buildings. Currently all municipal buildings are eligible for this benefit but the bill would limit the obligation to just one municipal building; and

WHEREAS, A3766/S2664 would eliminate the requirement that cable companies provide basic service and internet to municipal buildings and schools at no charge; and

WHEREAS, A3766/S2664 does not require the cable companies to provide a return feed to allow cable-casting of live municipal events and meetings; and

WHEREAS, A3766/S2664 would reduce the franchise fee payable by certain cable companies that have converted from a traditional franchise to a system-wide franchise; and

WHEREAS, A3766/S2664 does not require cable companies to meet or surpass any existing line extension policy or to meet any applicable consumer protection requirements, all of which are required by the current law; and

WHEREAS, The proposed verification process for determining whether a company is operating in a "competitive franchise area" is inadequate; and

WHEREAS, The proposed process for renewal of a system-wide franchise must be corrected to require that the renewal be under the same terms and conditions as the original franchise; and

WHEREAS, A3766/S2664 eliminates the right of a municipality operating under a municipal-consent based franchise to petition the BPU for a higher franchise fee;

NOW, THEREFORE, BE IT RESOLVED, That Liberty Township calls on the legislature to amended S-2664 A-3766 to ensure that all the commitments of NJSA 48:5A-28 be provided a) upon application for a system-wide franchise, (b) upon renewal of a system-wide franchise and (c) upon conversion of a municipal-consent based franchise to a system-wide franchise; and

BE IT FURTHER RESOLVED, That Liberty Township strongly urges the legislature to oppose A3766/S2664 until such amendments are made and there has been an opportunity for all stakeholders to fully analyze the impact of these proposals and; determine the fiscal impact of the bill on municipalities throughout the state; and
