A regularly scheduled meeting of the Township of Liberty was held in the Municipal Building, 349 Mountain Lake Road, Great Meadows on 4 May 2017. The meeting was opened by Mayor John Inscho with Adequate Notice of Meeting and the Pledge of Allegiance at 7:04 p.m.

REPORTS

COMMITTEEPERSON KARCHER

Pete Karcher presented a request from the Recreation Commission to reserve the John R Fisher Pavilion on 14 June at 6:00 pm to conduct a yoga session. The session would be at no cost to the participants. Following discussion, a motion by Carl Cummins to approve the reservation of the Joh R Fischer Pavilion for a yoga session on 14 June as conducted by the Recreation Commission carried.

COMMITTEEPERSON PETERSEN

Ron Petersen reported that Ferriero Engineering is working on a dam decommissioning concept plan.

COMMITTEEPERSON CUMMINS

Carl Cummins reported that Pequest Road paving project is scheduled for the week of 22 May. He also stated that the May LandUse meeting had been canceled.

MAYOR INSCHO

Mayor Inscho reported that he had attended a meeting between Allamuchy, Independence and Liberty looking for financial support to oppose the Highlands Plan. Liberty Township is not interested in participating.

DEPARTMENT OF PUBLIC WORKS

A pre-printed report was received from the Department of Public Works for April 2017 and placed on file.

ENVIRONMENTAL

A pre-printed report was received from the Environmental Commission for April 2017 and placed on file.

SOLITUDE LAKE MANAGEMENT CONTRACT

The Environmental Commission presented a one-year renewal contract between the Township of Liberty and Solitude Lake Management for a two (2) acres treatment area including the beach and boat launch. The management will focus on seasonal herbicide treatments for control of submersed and floating vascular aquatic plants including Curly leaf, leafy pondweed, coontail, water lilies, spatterdock and slender naiad. Copper sulfate will be permitted for algae control. A Solitude biologist will visit the site and inspect two times per month during the months of May through August. The contract pricing is \$1,980.00 with payment terms of \$495.00 per month May through August which would be paid through the Environmental Commission budget. Following discussion, a motion by Ron Petersen authorizing Mayor Inscho to execute said contract carried. Carl Cummins abstained.

Laketoberfest

Discussion from the Township Committee meetings of April 6 and 27, 2017 regarding Laketoberfest continued. The following topics were discussed;

- ✓ DASH Multisport has no insurance policy. DASH Multisport would be responsible for participant safety. DASH is to investigate an insurance policy.
- ✓ A facility application has not been filed for the Laketoberfest event.
- ✓ Attorney Skoog asked how crowd control would be monitored for the triathlon. Shannon Schaaf advised that Mountain Lake Fire Police would conduct traffic control and parking monitoring.
- ✓ Attorney Skoog inquired into water safety for the triathlon. Shannon Schaaf advised that Oxford Emergency Squad would be responsible for safety in the water. Independence First Aid squad services would also be on site. Warren County OEM and Washington Barracks of NJSP have been notified of the scheduled event.
- ✓ Shannon Schaaf reported that residents along the route would be receiving a mailer informing them of the schedule event. She stated that signage would be posted indicating a one-way directional during the triathlon. She stated that signs posted would be promptly removed following said event.
- ✓ She indicated that no minors would be participating in the event.
- ✓ She stated that no road paint would be used. Roads would be marked with chalk.
- \checkmark Food would be provided by Two Rivers catering for the triathlon
- ✓ There will be no alcohol available at the triathlon upon township property at the triathlon. Ms. Schaaf will have to pursue the firehouse for alcohol consumption on their property.
- ✓ DASH Multisport agreed to provide an insurance policy for the triathlon
- ✓ Laketoberfest DASH Multisport was asked to provide a \$3 million policy
- ✓ Laketoberfest and triathlon would be required to have a hold harmless document signed by all volunteers and participants naming Liberty Township as non-responsible.
- ✓ Laketoberfest will be re-visited at the next meeting in June 2017.

Following extensive discussion and review, a motion by Ron Petersen to authorize the Mountain Lake Community Association to conduct their second annual triathlon within the Mountain Lake area with the following conditions carried;

- ✓ A hold harmless document must be received from DASH Multisport releasing Liberty Township as well as a hold harmless document signed by each participant
- ✓ It will be noted on all publication, advertisements, notices, social media postings, etc that this triathlon is not sanctioned by the Township of Liberty.
- ✓ DASH Multisport shall provide Liberty Township with a certificate for the triathlon.

WHEREAS, N.J.S.A. 40A: 5-4 requires the Township Committee of every local unit to have made an annual audit of its books, accounts and financial transactions; and

WHEREAS, the Annual Report of Audit for the year 2016 has been filed by a Registered Municipal Accountant with the Municipal Clerk pursuant to N.J.S.A. 40A:5-6 and a copy has been received by each member of the Township Committee; and

WHEREAS, R.S. 52:2788-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs; and

WHEREAS, the Local Finance Board has promulgated N.J.A.C. 50:30-6.5, a regulation requiring that the Township Committee of each municipality shall, by Resolution, certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled "Comments and Recommendations"; and

WHEREAS, the members of the Township Committee have personally reviewed, as a minimum, the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations", as evidenced by the group affidavit form of the township committee attached hereto; and

WHEREAS, such resolution of certification shall be adopted by the Township Committee no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

WHEREAS, all members of the Township Committee have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local Township Committee to the penalty provisions of R.S. 52:27BB-52 to wit:

"R.S. 52:27BB-52. A local officer or member of a local Township Committee who, after a date fixed for compliance, fails or refuses to obey an order of the Director of Local Government Services, under the provisions of this Article, shall be guilty of a misdemeanor and, upon convictions, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office".

NOW, THERFORE, BE IT RESOLVED, That the Township Committee of the Township of Liberty hereby states that is has complied with N.J.A.C. 5:30-6.5 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.
