# LIBERTY TOWNSHIP LAND USE BOARD

## Minutes – October 20, 2015

The Liberty Township Land Use Board met for a regular meeting on Tuesday, October 20, 2015 in the Municipal Building 349 Mt. Lake Rd, Great Meadows, and N.J. The meeting was opened by Chairman Sosnovik at 7:31 p.m. and it was declared that all aspects of the Open Public Meeting Act had been met by posting notice of this meeting on the bulletin board in the Municipal Building and notifying the Municipal Clerk. ## **RESOLUTION:**

A motion was made by Mr. Beyer to approve the conditional Resolution (Docket 04/15) as written. Mr. Schaaf seconded the motion with roll call as follows:

Revised maps have been received and distributed. There are still outstanding conditions which have to be met such as documentation of access easements and portions of the property vacated by the Township.

#### **DISCUSSION:**

*Update on Master Plan Revisions, Eric Snyder, PP*: Planner Snyder noted that COAH has fallen apart and there are no guidelines to follow. Liberty has approximately 20 total acres that are not in the preservation area. Between 2000 and 2014 we had a total of 122 new homes built. Mehl's trailer park at the Lake is now gone. We lost the Casino and the General Store. There is new commercial construction taking place by John Cory. In the last 15 years we have had no new commercial ratables. Revisions are also being made to our fee schedule to eliminate separate line items for sheds and decks and to increase some of the escrow fees. We have had a slight decrease in population. Township attorney, Roger Skoog, will be copied on all correspondence for the proposed revisions. This will be discussed further at the November 23<sup>rd</sup> meeting.

**Land Use Board Administrator/Secretary Position:** Mrs. Dossena stated that we have two resumes to consider and we should schedule interviews for the November 23<sup>rd</sup> meeting. The time of the interviews will be determined when we know if/what other business will be conducted that evening.

**OPEN TO PUBLIC**: (8:26 pm) As there was no one in the audience, this portion of the meeting was immediately closed.
