# Liberty Township Recreation Commission Regular Meeting Minutes August 24, 2010

Chairman Doyle called the meeting to order at 7:14 PM in accordance with the Sunshine Law.

**Roll call** Present: Chairman Mike Doyle, Al Crisafulli, Mike Scudder, Charles Lindow, Andrew Cassini, Committee Liaison Mark Tibak Absent: Dave D'Olivo (excused)

**Minutes** The minutes of July 27, 2010 were approved as corrected on a motion by Mr. Scudder, seconded by Mr. Lindow, with all in favor.

### Reports

**Baseball**- Mr. Crisafulli has not yet been reimbursed for the referee fees he paid out of pocket totaling \$450 for two referees for 5 games at \$25 per game.

**Basketball-** A bill was received from Great Meadows Regional School District for use of the gym on Saturdays. The dates will be confirmed before the bill is paid.

**Soccer-** Mr. Cassini reported the Division IV 5<sup>th</sup> /6<sup>th</sup> grade girls team has 9/10 players, but no coach. Parents have been contacted, but no responses have come forward. After discussion the consensus of the Commission was that no 5/6<sup>th</sup> grade girls team will be fielded due to lack of a coach, if no one answers an email by 7PM the following evening. Refunds will be processed. The 3/4<sup>th</sup> grade boys team has 17 players, but the parents are receptive to rotating the schedule to keep 14 players per game. The keys from last year were not turned in. Uniforms have been ordered through John Salvia. Mr. Lindow made a motion to approve \$550 for games balls and line paint, seconded by Mr. Crisafulli with all in favor. Seven refunds are being processed. Kindergarten signups are still open. Mr. Scudder made a motion to approve Greg French and Seth Cubbage as coaches, pending background checks, seconded by Mr. Crisafulli, with all in favor.

Summer Recreation: The final report was submitted.

**Boat Launch:** A message board was obtained by the Open Space Committee, and installed by the DPW.

**Beach**- The job description for the subcommittee will be reviewed at the next meeting. **Concession-** Will start back up for soccer games beginning Sept. 11.

**Basketball Courts-** repairs have started and the fence needs a new bottom runner at an additional \$600.

**New Rec league:** The chair went to the Independence Rec meeting, but it was cancelled.
