**Minutes**

The minutes of February 24, 2015 were approved as corrected on a motion by the Chair, second by Ms. O'Byrne with all in favor.

**Correspondence**

Field use request - Carol Chobot for July 4. Approved on a motion by the Chair, second by Ms. Pandorf, all in favor. Certificate of insurance must be provided; rest rooms will not be opened. Code Green- Annual contract approved - motion by the Chair, second by Mr. Doyle, all in favor.

**Reports**

Baseball- Mr. Crisafulli reported he has stepped down as League VP and All Stars coordinator. Games will begin April 18 on the 50/70 field. League fee of \$875 were approved on a motion by Mr. Doyle, second by Mr. Gaeta, all in favor. The following coaches were approved on a motion by Mr. Doyle, second by Mr. Gaeta, all ion favor, Ms. O'Byrne abstaining: Al Crisafulli, Wayne Spangenberg, Brendan O'Byrne, Harvey Crowder, Chris Duval, and Bill Morgan. Umpire fees will be distributed as follows: \$360 each to Crisafulli, Connelly, Spangenberg, & O'Byrne; \$300 to Crowder- approved on a motion by Mr. Doyle, second by Mr. Gaeta, all in favor, Ms. O'Byrne abstaining

Soccer- Mr. Murphy reported registration will be held June 1- July 31, in-person dates will be June 10 & June 20. Referees are being sought.

Basketball- The season has ended and the Girls won the championship.

Beach- Lifeguard training will be offered at the end of May. Discussion was held on the Commission paying for the training if the guard works for a yet to be determined period of time. Water testing fees approved on a motion by the Chair, seconded by Ms. Pandorf, all in favor.

Fields- Quotes for enlarging the fields were reviewed. On a motion by Mr. Doyle, second by the Chair Chesney Contractors, LLC was approved for \$9,300 Funds being taken from ball field maintenance and sports equipment line items.

Community Day- Quotes for fireworks were reviewed. On a motion by the Chair, second by Ms. Pandorf Garden State Fireworks were approved unanimously.

Summer Recreation- PAIC training will be required as well as background checks for all staff. The existing discipline policy will be adjusted to include this program.

Background checks- Mr. Doyle is unhappy with the service provided by the company, but we have not been billed. Another company should be considered.
