# **RESOLUTION #2024.067**

OPPOSITION TO THE PROPOSAL BY THE DELAWARE RIVER NATIONAL PARK AND LENAPE PRESERVE ALLIANCE TO CHANGE THE DESIGNATION OF DELAWARE WATER GAP NATIONAL RECREATION AREA TO A NATIONAL PARK AND PRESERVE AND SUPPORT FOR ASSEMBLY BILL AR133 AND SENATE BILL SR93 WHICH OPPOSES ALL PROPOSALS TO CHANGE DESIGNATION OF DELAWARE WATER GAP FROM NATIONAL RECREATION AREA TO NATIONAL PARK AND PRESERVE, INCLUDING PROPOSAL FROM DELAWARE RIVER NATIONAL PARK AND LENAPE PRESERVE ALLIANCE

WHEREAS, on 1 September 1965, the United States and Congress enacted "An Act to Authorize Establishment of the Delaware Water Gap National Recreation Area and for Other Purposes." (DEWA) in order to, among other things, "Provide for outdoor recreation use and enjoyment... and for preservation of the scenic, scientific, and historic features contributing to public enjoyment of such lands and waters"; and

WHEREAS, the DEWA currently encompasses some seventy thousand (70,000) acres in New Jersey and Pennsylvania, including some fifty-four thousand (54,000) acres in Warren and Sussex Counties alone, and which offers a myriad of recreational opportunities such as hunting, fishing, swimming, camping, biking, hiking, walking, tubing, boating, skiing, bird watching, horseback riding, photographing, sightseeing, and hosts and promotes educational and other programs, including special events, and protects and preserves natural resources, endangered, threatened and rare species of plants, animals and other wildlife; and

WHEREAS, the new Delaware River National Park and Lenape Preserve Alliance plan which would establish the "Delaware River National Park and Lenape Preserve" ("re-designation Project") would limit or prohibit certain recreational activities in certain areas of the park; and

WHEREAS, there has been limited insight, information, communication, and clarification as to the scope and effect of said designation on issues of interest to the residents of Warren County; and

WHEREAS, the Re-designation Project does not address the agricultural, economic, and environmental impacts of said designation, the sources of funding, and proposed fees and charges for said use, and any and all plans for acquisition of public and private lands buy eminent domain or any other means, and the impacts said proposal and designation would have on hunting, fishing, wildlife

management, and active and passive outdoor recreation and educational activities generally and for the residents of Warren County specifically; and

WHEREAS, the Re-designation Project will reduce tax revenue, negatively impact enrollment of local school districts, and negatively impact the local economy of Warren County and the surrounding municipalities by reducing access to recreational activities

NOW, THEREFORE, BE IT RESOLVED that for the reasons outlines in this Resolution, the Liberty Township Governing Body opposes the proposal by the Delaware River National Park and Lenape Preserve Alliance to change the designation of the Delaware Water Gap National Recreation Area to a National Park and Preserve; and

# TREE ORDINANCE AS PER MS4

The Environmental Commission submitted a letter on 6 August 2024 with the following thoughts on the draft tree ordinance;

- 1. Open-ended applications for exemption, approval or permits beyond the limits of the 150-foot hazard zone. A landowner with a small improvement or development plan, involving removal of one or just a few trees, should have an opportunity to get relief short of having to file a site plan, if they can meet the approval criteria. For such cases, which are numerous, the ordinance might require a sketch or photos, and could include examples that may qualify for relief, such as adding more sunlight or space to a flower/vegetable garden, installing a patio, building a dog run, a swimming pool, adding a tool/garden shed, or similar activities.
- 2. Criteria for approvals: There should be some guidance or criteria to be used by the Land Use Board (or hearing officer) for granting relief from the ordinance, such as a finding that the "Proposed removal activities promote a beneficial use of the land without substantial detriment to the purpose of this Ordinance, taking into account the area disturbed and the area occupied by remaining existing trees on the property".

3. When a development requires a site plan based on other land use law: It might be wise to expressly indicate that when a development application requires a site plan under other land use law, it should be deemed to include a request for relief from the tree ordinance, so that there isn't a duplicate application required, or a conflict.

The Governing Body members were directed to review comments from the Environmental Commission regarding the proposed tree ordinance for discussion at the 3 October meeting.

NJDEP BUREAU OF SAFE DRINKING WATER BUREAU LEVEL 2 ASSESSMENT PENALTY An Administrative Order and Notice of Civil Administrative Penalty Assessment and a corresponding invoice for the amount of \$2000.00 was personally delivered to Liberty Township on 26 August 2024. Violations:

- Failure to conduct a Level 1 assessment as required by 40 CFR 141.859(a) and submit a Revised Total Coliform Rule Level 1 Assessment Form as required by PEA210001. (Very small – First Offense – Moderate Seriousness = \$500.00)
- Failure to conduct a Level 2 assessment as required by 40 CFR 141.859(a) and submit a Revised Total Coliform Rule Level 2 Assessment Form as required by PEA210002. (Very small – First Offense – Moderate Seriousness = \$500.00)
- Failure to conduct a Tier 2 Public Notification and submit a Public Notification Certification Forma s required by PEA230001 (Very Small – First Offense – Moderate Seriousness = \$500.00)
- Failure to conduct a Level 2 Assessment as required by 40 CFR 141.859(a) and submit a Revised Total Coliform Rule Level 2 Assessment Form as required by PEA230002. (Very Small First Offense Moderate Seriousness = \$500.00)

NJ DEPARTMENT OF LABOR AND WORKFORCE OSHA NOTICE OF ORDER TO COMPLY Jeff Snyder, DPW Supervisor, presented the NJ Department of Labor and Workforce OSHA Notice of Order to Comply following a general inspection on 31 July 2024. Citations included the following:

 Ladders were observed as being modified by cutting a longer ladder and removing the nonslip feet

- Exit was not clearly visible and marked by a sign reading "EXIT"
- Need to evaluate the workplace to determine if any spaces were permit-required confined spaces
- Drill press was not provided with a chuck guard to protect employees from the rotating shaft
- Extension cords were damaged at the female end and not removed from service
- Need to provide the required fire extinguisher training at the required frequency
- Need to assess the workplace to determine if hazards are present, or are likely to be present, which necessitate the use of personal protective equipment (PPE)

A re-inspection is scheduled for Tuesday, 17 September 2024

Jim Nicols – Mr Nicols commented on the drainage work performed by the DPW along Quenby Mountain Road. Mr Nicols requested speed limit signage be posted along Quenby Mountain Road. Mayor Inscho directed the DPW to post speed limit signs going down the hill.

Mary Sanford – Ms Sanford inquired when pot holes along Jenny Jump Avenue would be addressed. She also asked that yellow road lines be painted around Mountain Lake

Larry Supp - Mr Supp presented multiple questions on the Liberty Lake Dam breach report.

- ✓ The first ten pages of the report are unable to be read due to the reduction
- ✓ The report does not explain how the Engineer arrived at a proposed design or what the design is
- ✓ The report is missing pages
- The computation for Liberty Lake output within the report states that the computer data is outside the scope of what this software can handle
- The flowrate thru the dam equals the flow of water witnessed in the Peaquest River during Hurricane Floyd
- ✓ Who is responsible for the liability within this report

Chris Shand – Mr Shand requested the installation of 20 mph speed limit signs along Lakeside Drive West. Attorney Wenner will confer with the Dave Clark, Municipal Engineer, for location of signage along Lakeside Drive West.
